Tenders in sealed covers are invited for and on behalf of the Governor of Mizoram from the Flour Mills within Mizoram for lifting, milling of Wheat and delivery of finished products to the Department under Wheat Based Nutrition Programme (WBNP). The quotations will be received by the Director of Women and Child Development, Social Welfare & Tribal Affairs Department, Mizoram, Aizawl upto 5th August 2024, 12:00 PM and will be opened by the Director, Women and Child Development, Social Welfare & Tribal Affairs Department or his/her authorized representative at the same day on 2:00 PM. The tenderers or their authorized representatives may remain present at the time of opening of tenders if they so desire.

TERMS & CONDITIONS

- Tender should be submitted in sealed cover and the following words should be superscribed on the cover "TENDER FOR LIFTING, MILLING OF WHEAT AND DELIVERY OF FINISHED PRODUCTS" with Tender Notice No. and date.
- Rate should be quoted both in figures and in words. All corrections, if any, must be initialed and dated. Any error / overwriting in quoting rates and other compulsory documents in the tender will be treated as invalid.
- Rate should be quoted per 25 kg F.O.R. Aizawl as well as F.O.R. Lunglei inclusive
 of transportation costs (FCI Godown to Flour Mill and Flour Mill to Department's
 Godowns at Hunthar Veng, Aizawl and Lunglei), taxes, milling, fortification and
 packaging.
- Tenderers should submit HTPC and Professional Tax Clearance Certificate.
- The tenderer should attach attested copy of their milling license/industrial registration certificate. Original copy of the certificate mentioned above should be produced at the time of opening of tenders if demanded by the authority.

- Each firm or tenderer should submit only one tender on their behalf and submitting more than one tender by applicant firm/tenderer will be considered invalid and will not be accepted.
- 9. Tenderer should deposit 2% of bid amount based on quoted rate in the case of Tribal and 5% in case of Non-Tribal as Earnest Money in the form of Deposit at Call/Bankers Cheque duly pledged to the Director, Women and Child Development. The Earnest Money shall be refunded in the case of unsuccessful tenderers and shall be retained for the successful tenderer till the deed of agreement is signed and Security Deposit is made. In case of withdrawal of Tender i.e. after opening of Tender or withdrawal after selection and approval of the firm, the firm will be blacklisted from participating in subsequent tenders.
- 8. The cost of Wheat will be borne by the Department. The quantity to be milled will be as per the quarterly allocation made by the Government of India.
- 10. The milling percentage should be 89% Wheat flour, 9% Bran and 2% Refraction. The Bran will be at the disposal of the selected Miller.
- 10. In case of holiday on the specified date for opening the tender, the next working day shall be automatically considered as opening date. However, last date and hours for receiving the tender by the Director, Social Welfare & Tribal Affairs Department will remain unchanged.
- 11. The selected tenderer should deliver the finished products packed in food grade plastic bag weighing 25 kg wherein the words "SPECIALLY PACKED FOR SNP. NOT FOR SALE" should be properly and boldly labeled on the outside of the pack. Delivery of the finished products viz. Wheat Flour will be made at the Nutrition Godown of Social Welfare & Tribal Affairs Department, Aizawl and Lunglei respectively within one month after completion of lifting of Wheat for each quarter.
- 12. The finished product-wheat flour should be fortified with **Iron**, **Folic acid**, **Vitamin B 12 and Zinc.** A Certificate of fortification/premix used for fortification along with photo of the feeder used for fortification should be enclosed.
- 14. The Department reserves the right to inspect the mills and would have the right to reject the tender if found unsatisfactory.
- 14. The undersigned reserves the right to accept or reject any or all tenders without assigning any reason thereof and is not bound to accept the lowest rate.
- 15. The successful tenderers will have to execute a deed of agreement within one week from the date of issuing the intimation letter and should furnish security deposit to the tune of 2% of the total amount involved against the quantity allocated for each quarter (to be calculated on the basis of the price for sale of wheat under Open Market Sales Scheme Domestic issued by FCI from time to time), duly pledged to the Director, Women and Child Development in the form of Deposit at Call/Bankers Cheque.

- 16. The undersigned reserves the right to forfeit the whole or part of the Security Deposit for inadequate or unsatisfactory supply or for breach of any terms and conditions laid down by the Government as per agreement bond signed.
- 17. The losses sustained by the Department due to failure of the miller for not delivering the finished products in time for any reason whatsoever, will be recovered by the defaulting miller as fine or penalty as may be deemed fit and proper by the Government.
- 18. In case of dispute arising out of the operation of this Tender, the decision of the Govt. of Mizoram shall be final.
- 19. Payment will be made after successful delivery of the finished products by the successful tenderer. Under no circumstances revision of rates quoted by the tenderers would be permitted and the Department will not entertain such revision of rates.
- 20. For information of the successful tenderer, it is mandatory that the package of the selected food product should bear last-mile tracking through QR code in the delivery of packages of each food item, in compliance with streamlined guidelines dated 13th January 2021, for tracking of details such as composition of the food item delivered, date of manufacture, nutrition content and other relevant details.
