Tenders in sealed covers are invited for and on behalf of the Governor of Mizoram, competent and eligible manufacturers engaged in manufacturing of Energy Dense Fortified Food to be received by the Director of Women and Child Development, Social Welfare Department, Mizoram, Sikulpuikawn, Republic Road, Aizawl upto 1:30 P.M of 28th July 2020. The tenders will be opened by the Director of Women and Child Development, Social Welfare Department or his/her authorized representative at 2:00P.M on the same day. The tenderers or their authorized representatives may remain present at the time of opening of tenders if they so desire.

- Tender should be submitted in a sealed cover and the following words should be superscribed on the cover "TENDER FOR SUPPLY OF ENERGY DENSE FORTIFIED FOOD" with Tender Notice No. and date.
- 2. Rate for should be quoted both in figures and in words. All corrections, if any, must be initialed and dated. Any error / overwriting in quoting rates and other compulsory documents in the tender will be treated as invalid.
- 3. Rate should be quoted PER KG F.O.R. Aizawl as well as F.O.R. Lunglei. While quoting rates, it should be kept in mind that supply orders will be given in a phase manner for a period of at least 1 year. The rates quoted should be inclusive of all taxes and transportation costs.

- 4 Only genuine manufacturers are eligible for participating in the tender.
- The manufacturer should have fully automated, functional and operative manufacturing unit with technical expertise to manufacture or produce the micronutrient fortified Energy Dense Food ensuring zero contaminations. The bidder should produce a certificate from a Chartered Engineer.
- The bidder should have the capability to supply the food item in strict compliance to the guidelines issued by Ministry of Women and Child Deelopment and the judgement of the Hon'ble Supreme Court in the Shagun Mahila Case to ensure quality and hygiene standards of micronutrient fortified energy densed food.
- 7. Scheduled Tribe Tenderers should submit HTPC and PTCC and Non Tribal Tenderers should submit a non-refundable Court Fee Stamp worth Rs.200/-.
- 8. Scheduled Tribe tenderers and Non Scheduled Tribe tenderers should deposit a sum of Rs.1,50,000/- (Rupees one lakh fifty thousand) and Rs.3,00,000/- (Rupees three lakh) respectively for each item as Earnest Money in the form of Bankers cheque duly pledged to the Director, Women and Child Development, Social Welfare Department. The Earnest Money shall be released in the case of unsuccessful tenders and shall be retained for the successful tenderers till the deed of agreement is signed and Security Deposit is made as per requirement at Clause No.23 of the NIT. In case of sudden withdrawal of Tender (i.e. after opening of Tender) or withdrawal after the selection of the firm, the Earnest Money so deposited shall be forfeited.
- The bidder should have a proven track record of supplying at least 50 % of what is intended to be procured (approx. 138000kgs of Energy Dense Fortified Food manufactured and supplied under various Government Schemes during the last three years to Central /State Government. Copies of supply order and other proof should be enclosed.
- Income Tax Returns Acknowledgement for the last three financial years should be submitted. Tenderers should also indicate his / her GST registration number in the Tender Paper. Tenderers who have not cleared Tax up-to-date will be rejected. Proof of exemption, if any, should be enclosed with the tender. Original copy of the said certificates mentioned above should be produced at the time of opening tenders if demanded by the authority.
- 11. Tender form is not transferable. Tenderer should sign on all pages of the tender.

- 12. Energy Dense Fortified Food should contain not less than 500 kcal and 15 gms. of Protein per 100 gms. and should be fortified with micro-nutrients (Vitamins & Minerals).
- 13. Current year Certificate of Analysis of food from Government or NABL Accredited Laboratories clearly indicating the Protein, Calorific and Micronutrients (vitamins & minerals) contents should be submitted. Test Certificate should conform to specification of the N.I.T. The Certificate should be duly attested by Gazetted Officer. Original copy of the Certificate should be produced at the time of opening of tenders if demanded by the authority.
- 14. Sample of not less than 500 grams pack should be submitted. Nutritive value and composition of food, date of manufacture with expiry, net weight, shelf life, brand name and name of manufacturer should clearly be indicated on the cover of the sample. Sample should be submitted both for Aizawl and Lunglei if quoted.
- 15. Tenderers are to submit attested copies of the following documents.
 - vii) Manufacturing license.
 - viii) A valid license under FSSAI.
 - ix) ISO 9001/22000 Registration
 - x) HACCP Registration
 - xi) ISI Certificate
 - xii) GMP Certificate
- 16. The bidder should have in house quality control facilities, its own quality control laboratories equipped with appropriate laboratory facilities/infrastructure for testing the parameters prescribed in Food Safety and Standard Act and as per specification of the tender. Bidder must submit list of equipments and list of technically qualified personnel engaged for in-house quality control laboratory. A Certificate from Chartered Engineer should be produced in this regard.
- 17. In case of holiday on the specified date for opening the tender, the next working day shall be automatically considered as opening date. However, last date and hours for receiving the tender by the Director, Women and Child Development, Social Welfare Department will remain unchanged.

- 18. The selected supplier should supply the item wherein the words "SPECIALLY PACKED FOR SNP. NOT FOR SALE" should be properly and boldly labeled on the outside of the container of all items, and the following should be clearly indicated on the cover of each item:-
 - (i) Name of Manufacturer.
 - (ii) Composition of food.
 - (iii) Nutritive value of food.
 - (iv) Date of manufacture and expiry.
 - (v) Net weight.
 - (vi) Batch No.
 - (vii) Shelf Life.
- 19. The contract awarded to the successful tenderer should be executed by the tenderer himself. Subletting the work to any individual, firm will not be permissible.
- 20. The undersigned reserves the right to accept or reject any or all tenders without assigning any reason thereof and is not bound to accept the lowest rate.
- 21. The Department or its authorized representative may visit the bidder's manufacturing units and would have the right to reject the tender if found unsatisfactory.
- 22. The successful tenderers will have to execute a deed of agreement within one week from the date of issuing the intimation letter failing which the earnest money will be forfeited.
- 23. The successful tenderers shall have to furnish security deposit duly pledged to the Director, Social Welfare Department in the form of Banker's cheque as listed below:
 - (e) In case of Tribal to the extent of 5% of the total value of supply.
 - (f) In case of Non-Tribal to the extent of 10% of the total value of the supply.
- 24. The undersigned reserves the right to forfeit the whole or part of the Security Deposit for inadequate or unsatisfactory supply or for breach of any terms and conditions laid down by the Government as per agreement bond signed.

- 25. The undersigned reserves the right to increase or decrease the quantity to be supplied even during the validity of the supply order and also reserves the right to distribute the supply to more than one tenderer.
- 26. Sub-standard item will be rejected and the rejected item shall be removed by the supplier within two weeks from the date of rejection at his/their own cost. The Department will not bear any responsibility and expense. In case the rejected item / items are not removed, it shall be auctioned at the risk and responsibility of the supplier without any further notice.
- 27. Delivery of the items will be made at the Nutrition Godowns of Social Welfare Department, Aizawl and Lunglei respectively.
- 28. In case of dispute arising out of the operation of this Tender, the decision of the Govt. of Mizoram shall be final.
- 29. Energy Dense Fortified Food shall be properly packed in hermitically sealed, clean and sound container or in a food grade flexible pack in such a way as to protect it from deterioration repacked in a durable carton box of not more than 12 Kgs. Per box.
- 30. Under no circumstances revision of rates quoted by the tenderers would be permitted and the Department will not entertain such revision of rates.
